RESUMPTION OF ACADEMIC ACTIVITIES

Dear Parents/Guardians,

This is to bring to the notice of our dear Parents/Guardians that the new resumption date for academic activities for all new and returning students is Friday, October 7, 2022. As you may recall, it was previously scheduled for September 23, 2022 but was postponed to accommodate ongoing hostel renovation in the University. Please note the following policy directives:

- 1. UNIVERSITY POLICY ON RESUMPTION:** Resumption dates are mandatory and should be complied with. Early resumption, especially for new students, gives the students the opportunity to settle down, attend orientation programmes and familiarize themselves with the university environment before commencement of serious academic work. Late resumption will take effect from Monday, October 17, 2022 and will attract a fine of Twenty Thousand Naira (₦20,000.00) only.
- 2. ATTENDANCE AT LECTURES:** Please note that lectures begin in earnest on Monday, October 10, 2022. All students are expected to attend all classes as non-attendance is a serious offence and may attract suspension or barring from scheduled examinations. Parents of defaulters will be contacted.
- 3. DRESS CODE:** Students appearance at all times must be in accordance with the University dress code. No student is permitted with shorts or flip flops (bathroom slippers) in the Administrative Blocks or academic buildings in the University. Casual dressings are not permitted within the campus during official hours. (Students can obtain the list of dress prohibitions from the Students Affairs Division).
- 4. CLEANLINESS:** Every student is responsible for the tidiness of his or her clothes, beddings and room as well as the immediate surroundings. Littering of

the University is not acceptable. (Refuse baskets are provided at strategic locations across the campus).

5. USE OF BANNED SUBSTANCES (PSYCHOTROPIC DRUGS): Please note that Arthur Jarvis University has zero tolerance to the trafficking, usage or sale of banned substances, including psychotropic or mind-altering drugs. The penalty for students caught is expulsion. Culprits will also be handed over to the appropriate Law Enforcement Agency. Every student is responsible for reporting the use or sale of drugs in his or her room or immediate surroundings. Any student on prescription drugs should register such at the University Hospital.

6. CELEBRATIONS: The policy of non-celebration of birthday or other parties still stands. All students should please take note and kindly adhere.

7. USE OF UNIVERSITY FACILITIES: All students are expected to handle University facilities in the hostels, laboratories, libraries, classrooms, etc with care. Loss or damage to any University facility will attract a fine.

8. CRIMINALITY AND INVOLVEMENT IN FRAUD: Any student found to be involved in criminal activities like electronic/online fraud, theft of properties belonging to the University, staff or other students will be handed over to the appropriate law enforcement agency for further action(s). If culpable, necessary sanctions in line with the University laws will apply.

9. COOKING IN THE UNIVERSITY HOSTEL: For the safety of life and property of students and the University, the University maintains a policy that students are NOT allowed to cook in the hostel. This prohibition in force at all times. Students caught with any cooking appliance or in the act of cooking will be dealt with in line with University laws.


10. EXEAT FROM CAMPUS

On-campus students are not permitted to leave the University Campus without proper permit from the Students Affairs Unit. The Parent/Guardian will undertake full responsibility for the student's safety and conduct during the period of exit from the Campus. Unauthorized exeat from the University may attract sanctions, including suspension or expulsion from the University.

11. SELLING OR CARRYING OUT COMMERCIAL BUSINESSES IN THE HOSTELS: The University Management in recognition of the need to buy food and other daily needs has made adequate provision for students to make purchases from food vendors and shops at the University Mini Mart

(Tuck Shop) and new shopping complex. Therefore, students caught engaging in commercial activities like selling of food, drinks or beverages in the hostels will be appropriately sanctioned.
